The program officially launched in May 2022.

We're proud to offer the Caesars Makes Change program in our casinos nationwide to provide resources to organizations in the communities where we live, work and play."

In addition to the Caesars Makes Change and Foundation grant donation, Caesars Entertainment executives visited one of the Boys & Girls Clubs of Southern Nevada on July 31 to present Caesars Makes Change and Caesars Foundation gifts and volunteer with the Club kids.
